1. Reference is made to

- a. Subject Department of the Army permit issued 25 April 2013.
- b. Subject Department of the Army Permit Modification #1 issued 24 June 2013.
- c. The subject permittee's permit modification request dated 8 January 2014 to add twelve (12) commercial vessel mooring buoys and relocate the originally permitted four (4) for a total of sixteen (16) commercial vessel mooring buoys.
- d. USCG Sector New York Waterways Management Division's letter dated 13 JAN 2014 stating "no objection" to the new sixteen-buoy mooring field north and south of the ongoing bridge construction site.

2. In accordance with the provisions of Section 10 of the River & Harbors Act of 1899 (33 USC 403) and Section 404 of the Clean Water Act (33 USC 1344), the New York District of the U.S. Army Corps of Engineers issued the subject Department of the Army permit [Reference 1(a)] on 25 April 2013 to New York State Thruway Authority, and issued the first permit modification [Reference 1(b)] on 24 June 2013.

3. The additional regulated work requested at this time includes construction and installation of twelve (12) additional commercial construction barge and vessel

mooring buoys in the Hudson River and the relocation of all four of the previously authorized four (4) commercial construction barge mooring buoys because of the increase in the number of required on site work barges and vessels for the ongoing bridge construction as shown on the enclosed replacement permit drawing

4. Based upon an evaluation of the administrative record supporting the issuance of the subject permit, a review of the permittee's submitted materials in support of their permit modification request [reference 1(c)], the subject permit is hereby modified so that Permit Drawing 2 of 25 dated April 2013 and titled COMMERCIAL MOORING BOUYS is replaced and superseded with the enclosed Permit Drawing number 2 of 25 dated December 2013 and titled COMMERCIAL MOORING BOUYS.

5. All other terms, General Conditions, and Special Conditions of the subject issued permit shall remain in effect, including the permit expiration date of 24 MARCH 2019.

6. Going forth this modified permit shall be known as Permit Number NAN-2012-00090-M2.

7. This now twice-modified subject Department of the Army permit shall be available at project offices and regulated work sites.

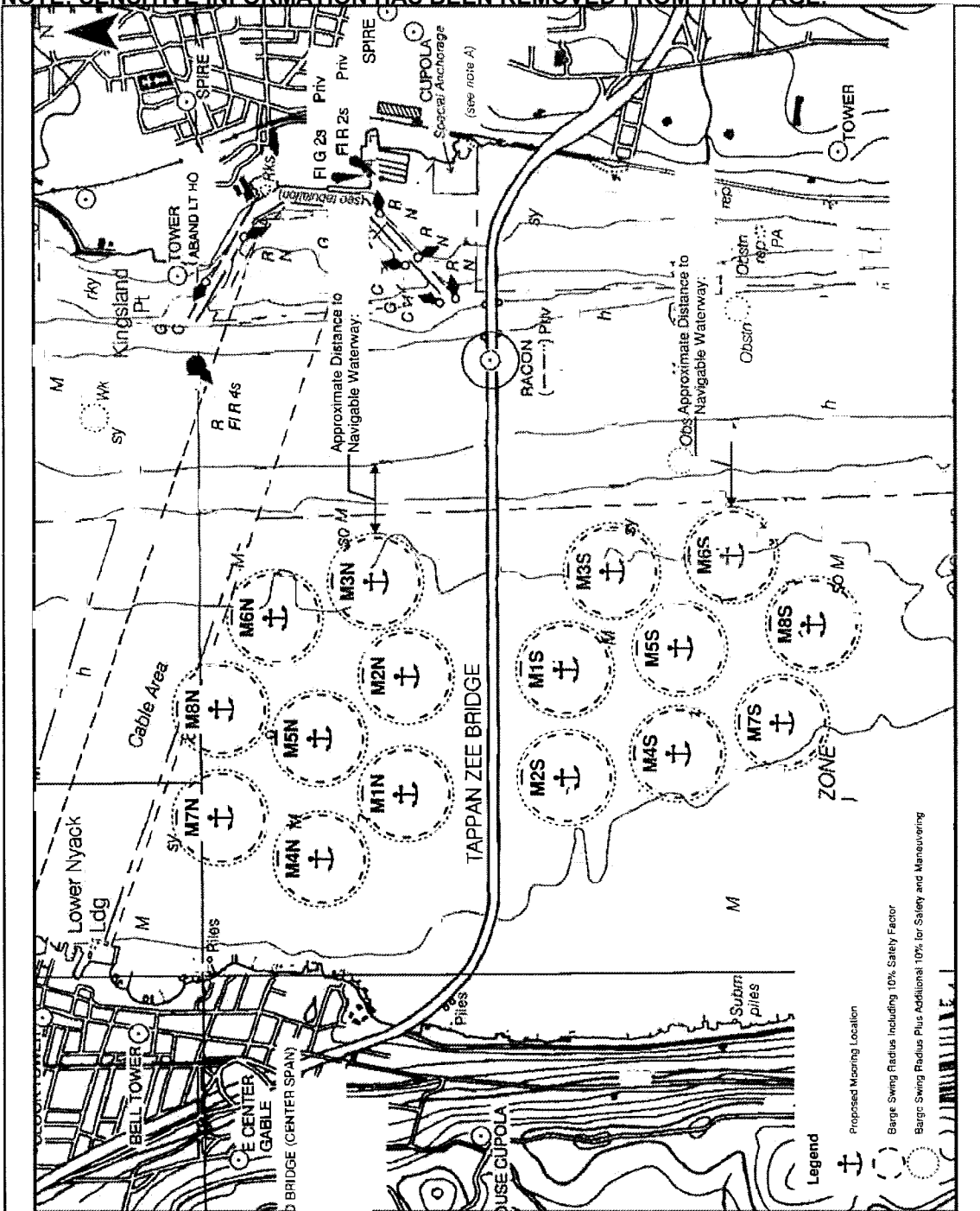
